Submission Requirements

Articles shall be submitted in Russian or English as MS Word files on 3-4 pages, in **Times New Roman font, size 14, single spacing**. All pictures and tables shall be numbered and provided with titles. Pictures shall be sent as separate source files to the Organizing Committee.

Article Structure

1. Indicate a UDC in the upper left corner of the article.
2. Article title (in capital letters, bold), center alignment.
3. Authors' full names (bold) indicating their academic degree, academic title, position and subdivision, and e-mail. Full name of the organization, address with zip code, city and country.
4. An abstract, including a short description of the novelty, materials and methods, research results and conclusions (a summary in Russian of at least 150 words). Keywords: 3-5 words.
Information shall be presented in Russian in items 2, 3 and 4.
5. Your article title, information on authors and organization in English. Abstract (a summary in English of at least 150 words). Keywords.
6. Main text of your article shall be presented in a certain sequence with corresponding subheadings in English.
 - 1) Introduction
 - 2) Materials and Methods
 - 3) Research Results
 - 4) Conclusion
7. References. References shall be listed alphabetically. The number of sources in the reference list shall include no more than 5 for the last 10 years.
